- 1. The contract term for the Customised Scheme is 5 years.
- 2. The contract term for the services subscribed under the Customised Scheme is 5 years.
- 3. There shall be no auto-renewal of any service(s) subscribed under the Customised Scheme.
- 4. No other discounts shall apply to the Customised Scheme.
- 5. The customer shall not resell the services subscribed under the Customised Scheme "as is" or as a standalone Dark Fibre service but may use the service as part of its own network to offer its own service(s).

- 6. The B-end shall not be a cable station, earth station, telephone exchange, manhole, room housing a main distribution frame, power room, lead-in pipe, ducting, at any outdoor site, or at any premises not owned by the customer. SingTel shall not entertain any request for termination of the service(s) at any such sites.
