Existing MetroEthernet circuits subscribed by the customer may be used to meet the minimum quantity required for the free head-end circuits under Table 1.

The customised tariffs are offered to the customer and its wholly-owned subsidiaries. Services subscribed under the Customised Scheme by the customer and its wholly-owned subsidiaries can be combined to meet the minimum quantities required.

## **Terms and Conditions:**

- 1. The contract term of the Customised Scheme is three (3) years.
- The contract term of the services subscribed under Table 1 of the Customised Scheme is three (3) years. The contract term of the services subscribed under Table 2 is as specified in the Table.
- 3. The customer is required to maintain a utilisation of 50% across each free head-end subscribed under the Customised Scheme. The customer will have 12 months from the start date of the Customised Scheme to hit the required minimum aggregate utilisation of 50%.
- 4. In the event that utilisation falls below 50%, the head-end will revert to prevailing list price, or the 1Gbps list price for the 2Gbps head end.
- 5. The services offered under the Customised Scheme are subject to resource availability.
- 6. The customer shall not resell the service subscribed under the Customised Scheme.

- 7. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
- 8. In the event that the customer terminates the service(s) subscribed under the Customised Scheme prior to the end of the circuit contract term, prevailing premature termination charges shall apply.
- 9. Circuits subscribed under the customised scheme will continue at the customised prices after expiry of the circuit contract term.
- 10. All other standard prices, terms and conditions of the Singtel MetroEthernet service shall remain applicable.

## **Eligibility:**

The Customised Scheme will be offered to all similarly situated customers who satisfy the following criteria:

- a) is a duly licenced Facilities Based Operator (FBO) or Services-Based Operator (SBO); and
- b) accepts the terms and conditions of the Customised Scheme in its entirety.
