The customised tariffs will be applicable to all new, renewed, and upgraded MetroEthernet circuits, and DigiNet circuits migrated to the Customised Scheme.

Relocation charges applicable for services subscribed under the Customised Scheme shall be the same as the OTC above.

The customer must commit to a minimum volume of at least 60 MetroEthernet (Tail-End) circuits within one (1) year. For the avoidance of doubt, DigiNet circuits migrating to the Customised Scheme shall count towards the minimum volume commitment.

Terms and Conditions:

- 1. The contract term of the Customised Scheme is three (3) years.
- 2. (with effect from 26 October 2018) The contract term of the MetroEthernet PTMP services subscribed under the Customised Scheme is three (3) years. The contract term of all MetroEthernet IGA services subscribed under the Customised Scheme is two (2) years.
- 3. There shall be no auto-renewal of the Customised Scheme.
- 4. The services offered under the Customised Scheme are subject to resource availability.
- 5. The customer shall not resell the services subscribed under the Customised Scheme.
- 6. (with effect from 12 December 2019) Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
- 7. If the customer is unable to meet the minimum volume commitment, the customer will be required to pay a shortfall based on the following formula:
 - Shortfall = (Minimum volume commitment actual subscribed circuits) * (Customised Price) * 12 months
- 8. All other standard prices, terms and conditions of the Singtel MetroEthernet service shall remain applicable.

Termination and Suspension Provisions

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term for the minimum volume commitment.

Upon meeting the minimum quantity of circuits required, the customer shall be eligible for a PTC waiver for any additional circuits subscribed under the Customised Scheme.

The customer shall be eligible for a PTC waiver of existing DigiNet circuits migrating to the Customised Scheme.
