After one (1) month, if the circuit to be relocated is still required by the customer, it will be charged at prevailing list price.
- 9. (with effect from 4 January 2020) Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
- 10. All other standard prices, terms and conditions of the Singtel Gigawave and MetroEthernet services shall remain applicable.
