Nominated Circuits

The customer may nominate up to 1,100 Meg@POP IPVPN EthernetLink circuits (**Nominated Circuits**) for a common contract end date subject to the following conditions:

- a. the contract end date is no earlier than 29 February 2020; and
- b. the circuit must have completed at least a one (1) year contract term by the end date.

For the avoidance of doubt, the Nominated Circuits may be subscribed at list price or under the Customised Scheme.

Nominated Circuits shall be subject to the following customised visitation and overtime charges:

Terms and Conditions:

1. The contract term of the Customised Scheme is two (2) years.
2. **(with effect from 12 December 2018)** The minimum contract term of the services subscribed under the Customised Scheme is as follows:
 - a. Meg@POP IPVPN EthernetLink (Temporary) service – one (1) month; and
 - b. All other Meg@POP IPVPN EthernetLink services – two (2) years.

3. The services offered under the Customised Scheme are subject to resource availability.
4. The customer shall not resell the services subscribed under the Customised Scheme.
5. **(with effect from 6 February 2020)** Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
6. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
7. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

Suspension and Termination Provisions:

In the event that the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the prevailing premature termination charges (PTC) shall apply.

The customer shall be eligible for a PTC waiver of up to 100 Nominated Circuits subject to the following conditions:

- a. circuit bandwidths eligible are 512k and 2M; and
- b. the circuit must have completed at least a one (1) year contract term.

Eligibility:
