Terms and Conditions:

1. The contract term of the Customised Scheme is three (3) years.
2. The contract term of the services subscribed under the Customised Scheme is one (1) year.
3. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as a standalone service but may use the service as part of its own network to offer its own service(s).
4. The service(s) subscribed under the Customised Scheme are subject to resource availability.
5. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
6. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
7. All other standard prices, terms and conditions of the Singtel Gigawave and MetroEthernet services shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the services subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a prevailing premature termination charge (**PTC**) of 100% of the remaining contract value.

Eligibility:

The Customised Scheme is offered to all similarly situated customers and their subsidiaries who satisfy the following criteria:

- a) subscribes to the minimum quantity as per the pricing table above;
- b) currently has or is willing to commit to a minimum annual spend of S\$1 million on Singtel Group services; and
- c) accepts the terms and conditions of the Customised Scheme in its entirety.

For avoidance of doubt, circuits subscribed by similarly situated customers and their subsidiaries can be combined to meet the minimum circuit and spending requirements. For similarly situated customers who wish to take up the Customised Scheme and similarly include their subsidiaries, it must define the list of subsidiaries.
