**Terms and Conditions:**

1. The contract term for the Customised Scheme is three (3) years.
2. **(with effect from 9 July 2019)** The contract term for the services subscribed under the Customised Scheme is as per the pricing tables.
3. **(with effect from 9 July 2019)** Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
4. **(with effect from 9 July 2019)** Circuits subscribed by the customer and its subsidiaries may be combined to meet the minimum quantities under the Customised Scheme.
5. No other discounts, but not limited to, term and volume discounts, shall apply to the Customised Scheme.
6. The customer shall not resell the service ‘as is’ or as a full or sub-bandwidth standalone Dark Fibre product.
7. The service(s) subscribed under the Customised Scheme are subject to resource availability.
8. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

### **Suspension and Termination Provisions:**

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge of 100% of the remaining contract term.
