For avoidance of doubt, the standard OTC will be waived for services subscribed under the Customised Scheme.

Terms and Conditions:

1. The contract term of the Customised Scheme is two (2) years.
2. The contract term of the services subscribed under the Customised Scheme is two (2) years.
3. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
4. The services offered under the Customised Scheme are subject to resource availability.
5. The customer shall not resell the services subscribed under the Customised Scheme.
6. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
7. All other standard prices, terms and conditions of the Singtel Meg@POP and MetroEthernet services shall remain applicable.

Suspension and Termination Provisions

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for prevailing premature termination charges.

Eligibility:

(with effect from 15 April 2020) The Customised Scheme is offered to all similarly situated customers and their subsidiaries and associates, who satisfy the following criteria:

- a) is willing to subscribe to a minimum of six (6) circuits under Table 1 and two (2) circuits under Table 2 as above, failing which, circuits will revert to the prevailing list price(s); and
- b) accepts the terms and conditions of the Customised Scheme in its entirety.

(with effect from 15 April 2020) For avoidance of doubt, circuits subscribed by the customer and its subsidiaries and associates may be combined to meet the minimum volume requirements.

(with effect from 15 April 2020) For similarly situated customers who wish to take up the Customised Scheme and similarly include its subsidiaries and associates, it must define the list of subsidiaries and associates.
