Terms and Conditions:

1. The contract term of the Customised Scheme is three (3) years.
2. The contract term of the services subscribed under the Customised Scheme is three (3) years.
3. **(With effect from 18 August 2021)** The customer shall subscribe to the minimum quantity of Dark Fibre circuits under Table A of the Customised Scheme. For the avoidance of doubt, where the customer subscribes to Table B services, the customer shall similarly subscribe to the minimum quantity of Dark Fibre circuits under Table B of the Customised Scheme.
4. One end of the services subscribed under the Customised Scheme must be connected to the customer's POP (Point of Presence) located at a data centre.
5. The customised tariffs are inclusive of diversity commitment (i.e. the Dark Fibre pairs will be routed along diverse points of entry at the customer's POP).
6. The customer shall not resell the service 'as is' or as a full or sub-bandwidth standalone Dark Fibre product.
7. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
8. The service(s) subscribed under the Customised Scheme are subject to resource availability.
9. No other discount including, but not limited to, term and volume discounts, shall be applicable to the service(s) subscribed under the Customised Scheme.
10. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (PTC) of 100% of the remaining contract term.
