- 1. The customised tariffs include any combination of Class of Service (**CoS**) that the customer wishes to apply to the circuit. For the avoidance of doubt, the sum of CoS bandwidths cannot exceed the bandwidth of the Meg@POP circuit.
- 2. The customer is also eligible for a waiver of the MRC and OTC for the following:
  - a. unlimited Ethernetlink Virtual Circuits (**EVCs**). In the event of an EVC reconfiguration, the customer shall be charged the prevailing reconfiguration charge; and
  - b. up to 100 eBGP prefixes per Meg@POP circuit.
- 3. (with effect from 23 October 2020) The customised tariffs will be applicable to all new, renewed and upgraded Meg@POP and MetroEthernet circuits subscribed under the Customised Scheme.

#### **Terms and Conditions**

- 1. (with effect from 14 October 2021) The contract term for the Customised Scheme is four (4) years.
- 2. The minimum contract term for the services subscribed under the Customised Scheme is one (1) year with an option to extend on a yearly basis for a maximum of two (2) extensions.
- 3. The customer shall not resell the services subscribed under the Customised Scheme.
- 4. The service(s) subscribed under the Customised Scheme are subject to resource availability.
- 5. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
- 6. (with effect from 8 November 2019) Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
- 7. (with effect from 23 October 2020) All other standard prices, terms and conditions of the Singtel Meg@POP and MetroEthernet services shall remain applicable.

#### **Suspension and Termination Provisions:**

- 1. (with effect from 18 February 2019) The customer is eligible for early re-contracts of up to fifteen (15) Meg@POP circuits without incurring any applicable premature termination charges.
- 2. Subject to the above, in the event the customer terminates any service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for the prevailing PTC.
