- 3. (with effect from 20 October 2021) The customer shall subscribe to the minimum quantities as stated in the pricing tables above.
- 4. The customer is not allowed to resell the services subscribed under the Customised Scheme.
- 5. The services offered under the Customised Scheme are subject to resource availability.
- 6. No other discounts, including term and volume discounts, shall be applicable to the Customised Scheme.
- 7. (with effect from 20 October 2021) The customer will be eligible for two (2) free circuits comprising 1 x 10G Gigawave with Path Diversity and 1x 2G Gigawave with Path Diversity if the customer subscribes to at least 1 x 10G Gigawave and 1 x 2G Gigawave under the Customised Scheme.
