4. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
5. The customer shall not resell the services subscribed under the Customised Scheme.
6. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
7. The services offered under the Customised Scheme are subject to resource availability.
8. All other standard prices, terms and conditions of the Singtel Gigawave service shall remain applicable.

#### **Suspension and Termination Provisions:**
