The customised tariffs will be applicable to all new, renewed, upgraded, downgraded and/or migrated Meg@POP circuits subscribed under the Customised Scheme.

**Terms and Conditions:**

1. The contract term of the Customised Scheme is two (2) years.
2. The contract term of the services subscribed under the Customised Scheme is one (1), two (2) or three (3) years as specified in the pricing table.
3. The customer shall subscribe to the minimum quantity of Meg@POP circuits under the Customised Scheme as specified in the pricing table.
4. The services offered under the Customised Scheme are subject to resource availability.
5. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
6. The customer shall not resell the services subscribed under the Customised Scheme.

7. The router(s) bundled under the Customised Scheme is subject to stock availability. Singtel reserves the right to replace the router with another model of similar or higher value. The customised tariffs include the circuit and router only. It excludes other charges such as installation and maintenance charges for the router.
8. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

**Suspension and Termination Provisions:**

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.

Notwithstanding the above, the customer is eligible for PTC and/or relocation OTC waivers for up to 10 Meg@POP circuits subscribed under the Customised Scheme per year, subject to the following conditions:

- a. Termination and/or relocation is due to project completion; and
- b. The circuits to be terminated and/or relocated have fulfilled at least 50% of their circuit contract term.
