4. **(with effect from 26 May 2022)** The customer shall subscribe to the minimum quantity of Gigawave circuits as per the pricing table above.
5. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
6. The services offered under the Customised Scheme are subject to resource availability.
7. The customer shall not resell the services subscribed under the Customised Scheme.
8. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed to the Customised Scheme.
9. **(with effect from 26 May 2022)** All other standard prices, terms and conditions of Singtel Meg@POP and Gigawave services shall remain applicable.

**Suspension and Termination Provisions:**

**(with effect from 26 May 2022)** If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for the following premature termination charges:

- b) Gigawave: 100% of the remaining contract term.
