- 3. (with effect from 6 June 2022) The customer shall subscribe to the minimum quantity of circuits specified under the Customised Scheme.

- 5. The services subscribed under the Customised Scheme are subject to resource availability.
- 6. (with effect from 6 June 2022) deleted

- 7. (with effect from 6 June 2022) If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for premature termination charges (PTC) of 100% of the remaining contract value.
- 8. (with effect from 6 June 2022) Notwithstanding the above, the customer is eligible for PTC of 50% of the remaining contract value for services subscribed under the Customised Scheme provided the service has fulfilled at least one (1) year of its contract term.

 - c. There shall be no extension after six (6) months. Thereafter, the customer shall terminate the existing service. Otherwise, prevailing list prices shall apply.
- 12. The customer is not allowed to resell the services subscribed under the Customised Scheme.
- 13. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the contract term.

- 14. (with effect from 6 June 2022) No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
- 15. All other standard prices, terms and conditions of the Singtel Gigawave service shall apply.
