- a. Meg@POP IPVPN eLite, Meg@POP IPVPN EthernetLink (standard), Multicast and Multicast + Access services: waive the OTC and up to one (1) month MRC
- b. All other services: waive the OTC and up to three (3) months MRC

Key Terms and Conditions:

- 1. Each customer can test each service free of charge for:
 - a. Up to one (1) month: Meg@POP IPVPN eLite, Meg@POP IPVPN EthernetLink (standard), Multicast and Multicast + Access services
 - b. Up to three (3) months: all other services
- 2. For all services except the Multicast service, should the customer need to test the service for a longer period, the customer shall be charged the prevailing list price of the service(s) for the additional period of testing in blocks of one (1) month. The additional period of testing will be as follows:
 - a. Capped at two (2) months: Meg@POP IPVPN eLite, Meg@POP IPVPN EthernetLink (standard) and Multicast + Access services
 - b. Capped at three (3) months: all other services

- 3. For the Multicast service only, no additional testing will be available. The Multicast service will be automatically terminated at the end of the one (1) month testing period.
- 4. Customers may choose to end the testing at any point in time without any additional charges by providing Singtel the prevailing notice period for the respective service.
- 5. Each customer can test each service under the POC scheme only once unless the customer is able to provide evidence of failure in the POC test, a change in their network equipment or cloud provider [during the period when the POC scheme is available] such that they would need to test the service again.
- 6. There is no limit to the number of services each customer can test under the POC scheme. It will be up to Singtel's discretion to determine the bandwidths provided to each customer to test under the POC scheme.
- 7. The services provided under the POC scheme are solely for testing purposes.
- 8. All circuits under the POC scheme must terminate at either the customer's premises or the customer's POP in a data centre.
- 9. The customer shall not resell the service(s) 'as is' or as a standalone service or resell the service(s) as part of its own network services.
- 10. The services offered under the POC scheme are subject to resource availability.
- 11. At the end of the test period, customers can choose to terminate or continue using the service(s) by signing on for at least the minimum prevailing contract term. For the avoidance of doubt, should the customer wish to relocate the service(s), the prevailing relocation charges shall apply.
- 12. Eligibility:
