- 4. The customer shall subscribe up to two (2) pairs of Dark Fibre services under the Customised Scheme. For the avoidance of doubt, the customer may take up the Customised Scheme for a maximum of one (1) time only.
- 5. The customer shall not resell the service 'as is' or as a full or sub-bandwidth standalone Dark Fibre product.
- 6. One end of the Dark Fibre services subscribed under the Customised Scheme must be connected to Seletar Earth Station.
- 7. The customer shall be charged USD \$800 per Dark Fibre pair as part of the service readiness charge.

- 8. The service(s) subscribed under the Customised Scheme are subject to resource availability.
- 9. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
- 10. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.
