Key Terms and Conditions:

1. **(With effect from 14 October 2021)** The contract term of the Customised Scheme is two (2) years.
2. **(With effect from 28 June 2023)** In the event that the customer takes up at least 20 pairs/ circuits as specified under the Customised Scheme within the initial contract

term of the Customised Scheme, the customer will be eligible to extend the contract term of the Customised Scheme for one (1) year.

3. **(With effect from 18 October 2024)** The contract term of the services subscribed under the Customised Scheme is as per specified in the pricing table.
4. **(With effect from 20 October 2021)** The customer shall subscribe to the minimum quantity of services as specified under the Customised Scheme.
5. **(With effect from 20 October 2021)** Services subscribed by the customer and its subsidiaries may be combined to meet the minimum quantity under the Customised Scheme.
6. **(With effect from 28 June 2023)** In the event the customer fails to meet the minimum quantity of 25 services as specified under the Customised Scheme, the customer shall be liable for a penalty charge calculated as per the following:
 - a. The customer's Customised Scheme is two (2) years - the penalty charge will be imposed at the end of the initial two (2) years contract term: $\$4,500 \times (25 - \text{Actual Quantity subscribed})$
 - b. The customer's Customised Scheme is two (2) years and extended by one (1) year - the penalty charge will be imposed at the end of the extended three (3) years contract term: $\$4,500 \times (25 - \text{Actual Quantity subscribed})$
7. The service(s) subscribed under the Customised Scheme are subject to resource availability.
8. **(With effect from 28 June 2023)** The customer shall not resell the service "as is" or as a standalone Dark Fibre or Videosonic service but may use the service as part of its own network to offer its services.
9. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
10. Services subscribed under the Customised Scheme will continue at the customised prices after expiry of the service contract term.
11. All other standard prices, terms and conditions of the Singtel Dark Fibre and Videosonic service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the services subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge of 100% of the remaining contract term.
