The customised tariffs will be applicable to all new, renewed, and upgraded Meg@POP services subscribed under the Customised Scheme.

The customer has the flexibility to pay the MRC for Meg@POP eLite services subscribed under the Customised Scheme in full or as an upfront OTC. For the avoidance of doubt, the upfront OTC will be the sum of the relevant MRC tier multiplied by the contract term. For example:

- Circuit subscribed for 12 months: Upfront OTC = 12-months' MRC tier x 12 months
- Circuit subscribed for 24 months: Upfront OTC = 24-months' MRC tier x 24 months
- Circuit subscribed for 36 months: Upfront OTC = 36-months' MRC tier x 36 months
- Circuit subscribed for 30 months: Upfront OTC = 24-months' MRC tier x 30 months

Key Terms and Conditions:

1. The contract term of the Customised Scheme is three (3) years.
2. The contract term of the services subscribed under the Customised Scheme is a minimum of 12, 24 or 36 months as specified in the pricing table above, with the option to extend for a minimum of one (1) month.

3. **(With effect from 12 January 2024)** The customer shall subscribe to a minimum quantity of 40 circuits in any combination as stated in the pricing table above within one (1) year from the start of the customer's agreement, and the total minimum quantity of 90 circuits within the 3-year contract term of the Customised Scheme, failing which all circuits subscribed under the Customised Scheme will revert to the prevailing list prices.
4. Services subscribed by the customer and its related companies can be combined to meet the minimum volume required.
5. The services subscribed under the Customised Scheme are subject to resource availability.
6. The customer shall not resell the services subscribed under the Customised Scheme.
7. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term. For the avoidance of doubt, should the customer take up the upfront OTC method of payment, upon expiry of the services, the customer will be charged according to the MRC in the pricing table above on a monthly basis.
8. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme before end of the contract term of the service(s), the customer will be liable for a premature termination charge (**PTC**) of 100% of the MRC for the remaining contract term.

Notwithstanding the above, the customer is eligible to enjoy PTC waiver for up to five (5) Meg@POP eLite services and two (2) Meg@POP EthernetLink services subscribed under the Customised Scheme subject to the following:

- a. the termination of service(s) arises from the customer being unable to continue occupying the premise due to the end of the building lease.

If the customer subscribes to the services under the Customised Scheme under the upfront OTC mode of payment, in the event the customer terminates the service(s) before the end of the contract term of the service(s), monies already paid will not be refunded.
