<b>Description:</b>	Customised Meg@POP and Ethernet Line Service Scheme ( <b>Customised Scheme</b> )

**Prices (including discounts):**

The customised tariffs are detailed in Annex 2.

The customised tariffs are offered to new, upgraded and renewed Meg@POP and Ethernet Line services subscribed under the Customised Scheme.

**Key Terms and Conditions:**

1. The contract term for the Customised Scheme is two (2) years.
2. The contract term for the services subscribed under the Customised Scheme is as specified in the pricing tables.
3. The customer shall have a minimum spending of \$3.2 million on Singtel and SingNet services by the end of the customer's Customised Scheme. In the event that the customer does not achieve the minimum spending upon the expiry of the customer's Customised Scheme, the customer shall pay the remaining amount to make up the required spending, i.e. \$3.2 million minus the customer's total spending on Singtel and SingNet services during the contract term of the Customised Scheme.
4. The customer is not allowed to resell the services "as-is" or as stand-alone services.
5. The customer may subscribe up to three (3) free 1 Gbps Ethernet Line PTMP head-end circuits under the Customised Scheme, subject to the following conditions:
  - a) The customer shall subscribe to at least one (1) Ethernet Line PTMP tail-end circuit under the Customised Scheme in the same order;
  - b) The overall utilisation of all free Ethernet Line PTMP head-end circuit(s) shall be at least 50% at the end of the first year of the minimum two-year contract term of each new head-end circuit;
  - c) In the event that the customer is unable to meet the overall utilisation of 50% described above, one (1) 1 Gbps head-end circuit will be charged at \$1,500 from the second year onwards;
  - d) The applicable standard activation OTC is \$2,000; and,
  - e) The customer may subscribe to additional free head-end circuit(s) under the Customised Scheme provided that:

- the overall utilisation of all existing free Ethernet Line PTMP head-end circuit(s) subscribed under the Customised Scheme is at least 50%; and
- the new free head-end circuit(s) is subject to conditions b), c) and d) above.

For the avoidance of doubt, there is a maximum quantity of three (3) free 1 Gbps Ethernet Line PTMP head-end circuits under the Customised Scheme.

6. Services subscribed under the Customised Scheme will continue at the customised prices after expiry of the service contract term.
7. The services subscribed to under the Customised Scheme shall be subject to resource availability.
8. Migration of Service: Premature Termination Charges (**PTC**) and One Time Charge (**OTC**) shall be waived for the Meg@POP and Ethernet Line services under the Customised Scheme, subject to the following conditions:
  - a) The service must be within the same location used to serve the same end user of the service; or
  - b) If the migrated service is at a different location (new end user site(s)) from the existing service location, the customer must produce evidence satisfactory to Singtel that the end user is relocating from the original end user site(s) to the new end user site(s); and
  - c) The contract value of the service migrated to must not be lower than the contract value of the remainder of the contract term for the existing service; and
  - d) The monthly recurring charge of the service migrated to must not be lower than the contract monthly recurring charge of the existing service; and
  - e) The service migrated to shall have a new minimum subscription period with a start date from the date of migration.
9. For Ethernet Line Point to Point (**PTP**) services, relocation charges shall apply subject to the following conditions:
  - a) The customer can request for relocation of one end of the service. The relocation charge shall be equivalent to the standard OTC (1-year).
  - b) Relocation of both ends of the service shall be deemed to be a request for the termination of that service and a request for the supply of a new service at the requested location. The PTC shall apply to such request for relocation of both ends of the service.
10. For Meg@POP services, the following relocation charges shall apply:
  - a) The relocation charge shall be equivalent to the standard OTC (1-year) of the applicable service and bandwidth.
  - b) Relocation of tail-end circuit: The customer must produce evidence that the customer's end user is relocating from the existing location to the new location, failing which the request for relocation shall be deemed as a request for termination and a request for new supply of the service at the requested location. In such an event, the PTC shall apply.

11. The one-time relocation fee shall be waived for Meg@POP and Ethernet Line services subscribed under the Customised Scheme if the relocation orders and services renewal are submitted together as one single order. The one-time relocation fee waiver can only apply if the relocated circuit is used by the same end user.
12. For Ethernet Line PTP services, one end must be at the customer's end user's premises ("**A-End**") and the other end must be at the customer's POP premise ("**B-End**").
13. All other standard prices, terms and conditions of the Singtel Meg@POP and Ethernet Line services shall remain applicable.

### **Suspension and Termination Provisions:**

In the event that the customer terminates a circuit subscribed under the Customised Scheme during the contract term, the customer shall be liable for PTC of 50% of the monthly recurring charges of the remaining contract term.

The Customised Scheme will be available to any similar situated customer who satisfies the following criteria:

- a) currently has a minimum revenue spend of \$6 million on Singtel Group services in the past 12 months prior to the start date of the customer's agreement;
- b) is a duly licenced Facilities-Based Operator (**FBO**) or Services-Based Operator (**SBO**);
- c) is a duly licenced Internet Service Provider; and
- d) accepts the terms and conditions of the Customised Scheme in its entirety.
