The customised tariffs will be applicable to all new and renewed Dark Fibre services subscribed under the Customised Scheme.

**Key Terms and Conditions:**

1. The contract term of the Customised Scheme is three (3) years.
2. **(With effect from 5 June 2025)** The contract term of the services subscribed under the Customised Scheme is three (3) years with an option to extend for an additional two (2) years.
3. **(With effect from 5 June 2025)** The customer shall subscribe to the minimum quantity of Dark Fibre services under Table A of the Customised Scheme in a single

order. Should the customer subscribe to services offered under Table B, the customer shall subscribe to the minimum quantity of Dark Fibre services as stated in Table B.

4. **(With effect from 5 June 2025)** Services subscribed under the Customised Scheme will continue at the customised prices after the expiry of the service contract term. For the avoidance of doubt, where the customer takes up ARC as the payment arrangement under Table A, the customer will be charged a monthly recurring charge of \$2,527 upon expiry of the Table A services.
5. The services subscribed under the Customised Scheme are subject to resource availability.
6. The customer shall not resell the services subscribed under the Customised Scheme.
7. In the event of relocation, the customer shall pay a relocation OTC of \$2,000.
8. No other discounts, including but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

#### **Suspension and Termination Provisions:**

If the customer terminates the services subscribed under the Customised Scheme during the contract term of the services, the customer shall be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.
