Under this Customised Scheme, the customer will be subscribing to a customised single provider-edge load balancing value-added service (**Customised VAS**) where each pair of EthernetLink circuits subscribed to the Customised VAS will consist of one standard EthernetLink circuit and one EthernetLink circuit with exchange diversity.

Should the customer require additional circuits, the following prices will apply for each pair of circuits as described in the service description above:

In the event that SingTel does not have the network resources to provide EthernetLink circuits with exchange diversity to the customer's requested site, the customer will subscribe to a pair of 2Mbps standard EthernetLink circuits with standard single provider-edge load balancing VAS for both circuits at monthly recurring charge of \$1,120 and one-time charge of \$1,500.

Qualifying Criteria:

1. The customer must have a minimum annual spending of at least \$4 million on SingTel services.
2. The customer must be migrating from its existing SingTel DigiNet and/or LATM services to Meg@POP service.
3. The customer must agree to be showcased in our marketing and/or publicity campaigns.

Key Terms and Conditions:

1. The Customised Scheme is offered to all retail customers and resellers who meet the above qualifying criteria, and agree to the following terms and conditions:
 - a) The minimum contract term of the circuits must be two (2) years.
 - b) Each site must have at least one pair of EthernetLink circuits, consisting of one Standard EthernetLink circuit and one EthernetLink circuit with exchange diversity.
 - c) Each pair of EthernetLink circuits subscribed per site must be of the same bandwidth.
 - d) The customer must subscribe to the Customised VAS for each pair of circuits.
 - e) The minimum bandwidth of the initial order of 20 circuits must be at least 3Mbps each. The minimum bandwidth of additional circuits must be at least 2Mbps each.
 - f) All initial requirements of 20 circuits must be ordered at the same time.
 - g) In the event that SingTel does not have the network resources to provide EthernetLink circuits with exchange diversity to the customer's requested site, the customer will subscribe to a pair of 2Mbps standard EthernetLink circuits with single provider-edge load balancing VAS for both circuits.
2. In the event the customer upgrades a circuit from a single PE load balancing with eBGP service scheme to a dual PE load balancing with eBGP service scheme before the end of the contract term, the premature termination charge shall not apply. All upgraded contracts will be deemed as new contracts with effect from the date the service is upgraded.
3. There will be no auto renewal of the Customised Scheme upon expiry of the contract. For any services required after the expiry of the contract term, the customer will have to re-negotiate the terms and conditions with SingTel.
4. All prevailing terms and condition of SingTel Meg@POP EthernetLink service shall remain applicable.
