Key Terms & Conditions

1. The minimum contract term of the Customised Scheme is two (2) years.
2. The minimum contract term of each Meg@POP EthernetLink circuit subscribed under the Customised Scheme is two (2) years.
3. The customised tariffs will be applicable to all new and renewed EthernetLink circuits.
4. Should the customer fail to maintain the minimum volume or revenue commitment during the contract term of the Customised Scheme, all circuits subscribed under the Customised Scheme shall revert to the prevailing list price of the service.
5. There will be no auto-renewal of the Customised Scheme upon expiry of the contract. For services that are required upon expiry of the contract, SingTel and the customer shall re-negotiate the terms and conditions prior to the expiry of the contract.
6. The customer is not allowed to resell the service(s) subscribed under the Customised Scheme.
7. The service(s) under the Customised Scheme are subject to resource availability.
8. All other standard terms and conditions of SingTel Meg@POP service and Meg@POP EthernetLink service shall remain applicable.

Eligibility:

The Customised Scheme will be offered to any similarly situated customer who meets the following criteria:
