(With effect from 8 December 2009) One-time relocation charge for migration of any DigiNet services: 50% off for circuits re-contracted for one (1) year; waived for circuits re-contracted for at least (2) years.

1. Prevailing one-time installation charges shall apply unless otherwise stated.
2. Only circuits subscribed under the Customised Scheme shall count toward the volume of circuits under the tiered pricing schemes.
3. The above tariffs are only applicable to new and renewal circuits. Renewal circuits must be renewed for a minimum one (1) year contract term to qualify.
4. The contract term for the Customised Scheme is three (3) years.
5. The contract term for the head-end circuits is two (2) years. The contract term for all other circuits subscribed under the Customised Scheme is one (1) year.

6. To qualify for a waiver of the head-end monthly recurring and one-time charges, the following conditions apply:
 - i) If the customer commits to subscribing to at least 120 tail-end circuits within eighteen (18) months of subscribing to the Customised Scheme, the monthly recurring charge for the head-end will be waived upfront.
 - ii) In the event that the customer does not meet this commitment by the 18th month, the customer will be required to pay SingTel a shortfall based on the following formula:

$$(120 - \text{actual volume of tail-end circuits}) * \$740 * 12 \text{ months}$$
7. Should the customer require express delivery of the services, the express one-time charge will be twice the one-time charges stated above.

Key Terms and Conditions:

1. (With effect from 8 December 2009) The upgrade is only applicable to an existing standard 155Mbps DigiLink service connecting the customer's POP to any data centre.
2. (With effect from 8 December 2009) The contract term for the upgraded 622Mbps DigiLink circuit is one (1) year from the date of the upgrade.
3. (With effect from 8 December 2009) The relocation waiver can only be applied once to each circuit.
4. (With effect from 8 December 2009) Circuits that are relocated under the Customised Scheme must be re-contracted for at least one (1) year from the date of the relocation.
5. The customer shall not resell the Customised Service "as is" or as a standalone DigiNet product but may resell the Customised Service as part of its own network services.
6. All other terms and conditions of the SingTel DigiNet service shall apply.

In the event the customer terminates any service offered under the Customised Scheme before the expiry of the service contract term, the customer shall be liable for a premature

termination charge of 100% of the remaining contract value in the first year of the package contract term and 50% of the remaining contact value in subsequent years.

Eligibility:

The Customised Service will be offered to customers who meet the following criteria:

- are a duly licensed Facilities Based Operator or Services Based Operator;
- accept the terms and conditions of the Customised Scheme in its entirety;
- use the Customised Scheme, with one-end connected to the customer’s POP, for the sole purpose of connecting to an International Gateway to provide international services; and
- currently have or are willing to commit to a minimum annual spend of no less than \$6 million on SingTel DigiNet services
