- 3. (With effect from 26 October 2010) The customer can subscribe to the temporary PhoneNet line for a minimum contract term of one (1) month.
- 4. The customised MRC of the PhoneNet line will be applicable to all PhoneNet lines subscribed during the contract term. The applicable MRC will depend on the number of PhoneNet lines as described above.
- 5. Should the customer require any additional PhoneNet VASes, the prevailing list prices and the minimum subscription of 3 months will be applicable to such VASes.
- 6. There will be no auto renewal of the Customised Package upon expiry of the contract. For any service(s) required after the expiry of the contract, the customer will have to renegotiate the terms and conditions with SingTel.
