- 5. No other discounts, including but not limited to any term or discount, are applicable to the aervices subscribed under this Customised Scheme.
- 6. All other terms and conditions of the SingTel DigiNet and MetroEthernet services shall apply.

### **Suspension and Termination Provisions:**

In the event the customer terminates any service subscribed under the Customised Scheme during the contract term, the customer shall be liable for a premature termination charge of 100% of the remaining contract value in the first year of the contract and 50% of the remaining contact value in subsequent years.

# **Eligibility:**

The Customised Scheme will be offered to any customer who satisfies the following criteria:

- is a duly licensed Facilities-Based Operator or Service-Based Operator;
