7. The price tier (where applicable) will be reviewed on a quarterly basis. The price for the quarter will apply to new and renewed circuits. For the avoidance of doubt, the price tier for the first quarter shall be determined by the total number of eligible service circuits in aggregate as at the day before the effective date of the Customised Scheme contract term.

8. A term discount of 5% will apply for circuits contracted for at least two (2) years.

Key Terms and Conditions:

- 1. The contract term for the Customised Scheme is three (3) years and the minimum contract term for each circuit subscribed under the Customised Scheme is one (1) year.
- 2. Circuits under Package 1 will continue to be charged at the customised price after the expiry of the initial circuit contract term for the duration of the Customised Scheme contract term. For the avoidance of doubt, if the circuit was not within contract when it was subsumed under the Customised Scheme, it will still be charged at the customised price.
- 3. Existing circuits must be re-contracted under the Customised Scheme in order to enjoy the customised prices under Package 2. However, the applicable premature termination charges will apply subject to paragraph 5. The Customer may also opt to complete the existing circuit contract term prior to re-contracting the circuit under the Customised Scheme. After the expiry of circuit contract term of a service under Package 2, the customer will continue to be charged at the applicable customised price until the Customised Scheme contract term expires.
- 4. All existing DigiLink, MetroEthernet and Meg@POP EVPL EthernetLink Point-to-Point with Premium Real Time Class of Service circuits will be automatically subsumed under Package 1 of the Customised Scheme. For the avoidance of doubt, the existing circuits need not be renewed under the Customised Scheme to enjoy the customised tariffs.
- 5. Only new and renewed Meg@POP IPVPN eLite, IPVPN iLink, IPVPN BizLink, IPVPN SymLink, IPVPN vLink and IPVPN EthernetLink will be subsumed under

Package 2 of the Customised Scheme. For the avoidance of doubt, the waiver of the premature termination charge for early re-contract will apply.

- 6. The customer is required to commit to the following minimum spending:
 - a) annual spend of at least S\$13M on DigiLink, MetroEthernet, Meg@POP and GigawaveLite services subscribed under the Customised Scheme for the duration of the Customised Scheme contract term; and
 - b) total 3-year spend of at least S\$52M on DigiLink, MetroEthernet, Meg@POP and GigawaveLite services subscribed under the Customised Scheme.
- 7. For the avoidance of doubt, the minimum spend will comprise of the spending from the customer and its subsidiary.
- 8. In the event that the customer fails to meet the minimum revenue commitment(s), the customer shall pay SingTel the shortfall.
- 9. Spending on value added services and One-time charges may not be counted towards the revenue commitment.
- 10. In the event that the customer opts to subscribe to services under Service Package 2 at the promotional price or list price, this expenditure will be counted towards the revenue commitment on condition that these promotional and/or list prices are lower than the customised prices. For the avoidance of doubt, spending on circuits subscribed under a promotion(s) that have expired and therefore reverted to list price will be counted towards the revenue commitment.
- 11. There shall be no auto-renewal for the Customised Scheme.
- 12. The customer shall not resell the services subscribed under the Customised Scheme "as is" or as standalone DigiLink, MetroEthernet and Meg@POP services but may use the services as part of its own network to offer its own services.
- 13. In the event that the prevailing list price for any service(s) offered under the Customised Scheme is lower than the customised price, either customer or SingTel may initiate negotiations with the other party, for the sole purpose of reviewing and determining the price that shall apply for future orders for that specific service. For the avoidance of doubt, any new prices negotiated will be filed for the IDA's approval.

14. Service Package 1:

- a) During the negotiation period, all new and existing circuits of the affected service(s) shall be charged at the prevailing list prices until the parties mutually agree in writing on the pricing for future orders.
- b) The new mutually agreed price shall apply to both new and existing circuits including upgrade and renewal orders from a mutually agreed date and will be included as part of the Customised Scheme.

15. Service Package 2:

- a) During the negotiation period, all new and upgraded circuits of the affected service(s) shall be charged at the prevailing list prices until the parties mutually agree in writing on the pricing for future orders.
- b) The new mutually agreed price shall apply to both new and upgraded circuits from a mutually agreed date and will be included as part of the Customised Scheme.
- 16. The one-time installation charge shall be waived for any bandwidth upgrade within the same service provided that service is at the same location, the upgraded service starts a new contract term from the date of upgrade and the upgraded contract value is higher than the remaining contract value of the existing circuit.

17. Relocation

a) Service Package 1

The customer may request for the relocation of one end of a service. The relocation charge shall be equivalent to the one-time installation charge as stipulated in Annex 2. Relocation of both ends of the Service shall be deemed to be a request for the termination of that Service and a request for the supply of a new Service at the requested location in which case the relevant premature termination and One-time charges shall apply.

b) Service Package 2

- Relocation of Tail End: If the customer requests for any Tail End to be relocated, the customer must produce evidence that the customer's end user is relocating from its existing location to the new location, failing which the request for relocation shall be deemed as a request for termination and a request for new supply of the Service at the requested location in which case the relevant premature termination and One-time charges shall apply.
- Relocation of Head End: If the customer requests for any Head End to be relocated, the request for relocation shall be deemed as a request for termination and a request for new supply of a new Service at the requested

- location in which case the relevant premature termination and One-time charges shall apply.
- For clarity, in the event that relocation and bandwidth upgrade of the service occur concurrently, the relocation terms shall continue to apply.
- b. All other terms and conditions of the SingTel DigiLink, MetroEthernet and Meg@POP retail and wholesale services shall apply.

Terms and Conditions for the Basic Outdoor Scheme

- 1. Customer is required to subscribe to the Basic Outdoor Scheme where installation is at a site that does not meet standard operating conditions of SingTel's standard indoor product specifications for DigiLink and MetroEthernet and Meg@POP EVPL EthernetLink services which includes, but is not limited to the following conditions:
 - a) Installation site is not within a building that has controlled temperature and/or humidity; or
 - b) Installation site at any outdoor area such as at or near the roadside, corridor, rooftop (including sheltered) and car park (including a covered car park) etc; or
 - c) Installation site is at any other area or location that is or may be exposed or vulnerable to sunlight and/or rain or other weather conditions.
- 2. The Basic Outdoor Scheme service shall not terminate at locations that are stated in the SRCA Form to be prohibited in respect of any standard product(s) such as any earth station, cable station, off-shore islands, telephone exchange, on equipment provided by a FBO or another service based operator, or at any sites not owned by the Customer, including (but not limited to) manholes, MDF rooms, power rooms, lead-in pipes, ducting, etc.
- 3. This scheme is offered to only FBO operating base stations. This shall include mobile base stations, WBA base stations as well as Hotspot WiFi or Mesh WiFi base stations.
- 4. Customer shall submit its application for the Basic Outdoor Scheme service to SingTel using the Basic Outdoor Scheme SRCA Form containing no less than the following information:
- (a) Customer's name and address;
- (b) Exact installation addresses (or locations if there is no official mail-able address) of A End and B End;
- (c) Customer's contact details; and
- (d) Documentation necessary to enable SingTel to access the site where service is to be provided.

- 5. All other Standard Product Terms and Conditions apply.
- 6. The Basic Outdoor Scheme service is not provided with any Service Level Guarantee (SLG).
- 7. Any new infrastructure set up to fulfill the Customer's order for the Basic Outdoor service at the required locations shall remain the property of SingTel, with SingTel possessing sole rights over its use of the infrastructure even if the cost is borne by the Customer.
- 8. The Customer shall be responsible in taking preventative measures to minimize any risk of failure to SingTel's terminating equipment, taking into consideration that the service works best within the standard indoor scheme conditions (see note 16) which are stated in our standard product specifications so as to limit the number of on-site visits and/or ensure that no other services shall be adversely affected.
- 9. SingTel shall provide a target service level (**SL**) for the Basic Outdoor Scheme that Service restoration shall typically not exceed more than 6 hours for DigiNet, MetroEthernet and Meg@POP EVPL EthernetLink Point-to-Point with Premium Real Time Class of Service with the exception of those parts of the network that are outdoor where SingTel may have limited accessibility due to site conditions which includes but is not limited to either the Customer not being at site, or where SingTel's personnel / contractor are unable to be on site such as the roof top after office hours. This SL does not come with any rebates or any compensation or entitle Customer to make any claim for loss or damage in the event it is not met by SingTel.
- 10. Customer accepts the full risk and responsibility of placing or using the equipment in any area or place whatsoever where it could be lost, damaged, stolen, defaced, or otherwise rendered defective. Should any of such events occur, Customer shall be liable to pay SingTel all repair and replacement charges incurred in respect of any such affected SingTel equipment.
- 11. Due to the need for Customer to take over the responsibility of the terminating unit, the Customer must be present on site to accept the commissioned link after successful installation of any equipment hereunder at the appointed or agreed time of installation.
- 12. Customer will be liable for visitation or labour charges for any maintenance work which required activation of field staff at the rooftop installation site. Standard call out rates (both visitation and labour charges) are as follows:
- a) During office hours:

- 13. There shall be no maintenance work from 6 pm to 8.30am on any day (Monday–Sunday) if the installation site is a rooftop.
- 14. Subject to prior notification to and consent of the Customer, whenever required by SingTel, the Customer must ensure that SingTel's authorized personnel be permitted to enter any premises occupied or controlled by the Customer at such a time as may be specified by SingTel and to remain safely on such premises for such period as may be required:
 - (a) to carry out any inspection, repair, replacement or testing of any Basic Outdoor Scheme service and / or SingTel equipment and any other equipment relevant to the provisioning of the Basic Outdoor Scheme service;
 - (b) to check and verify the manner in which the service is being utilized, redistributed or provided as the case may be by the customer;
 - (c) to install, collect, remove, maintain or replace any equipment and or;
 - (d) for any other purposes in relation to the Basic Outdoor Scheme Service.
- 15. In the event that SingTel's authorized personnel or contractor is unable (at the date and time specified in any such appointment) to gain access to the site or to carry out such installation, inspection, maintenance, repair or replacement for any reason not attributed to SingTel or its personnel or contractor, SingTel may at its discretion, charge the Customer such call-out fee for the visit of SingTel's personnel or contractor to the site premises on that date at SingTel's then prevailing rate.
- 16. Standard Indoor (Air-con) Specification:
 - (a) Temperature: Up to 22 °C;
 - (b) Relative Humidity: Up to 45%, non condensing;
 - (c) Proper dedicated neutral and a grounding grid should be provided;
 - (d) No exposure to direct sunlight and rain;

- (e) Proper Water proofing to prevent water seepage;
- (f) Secured location or enclosure to prevent unauthorized access to avoid theft and vandalism;
- (g) Dust free;
- 17. Proper grounding for static discharge to prevent damage to equipments

Suspension and Termination Provisions:

- 1. In the event that the customer terminates a circuit subscribed under the Customised Scheme prior to the end of the contract term, the customer shall be liable for the prevailing premature termination charges for DigiLink and MetroEthernet, and a premature termination charge of 50% of the remaining contract value for Meg@POP.
- 2. The premature termination charge and one-time charge may be waived under the following circumstances:
 - a) Migration of 2Mbps DigiLink to MetroEthernet Point-to-Point (10Mbps to 100Mbps) or Meg@POP EVPL EthernetLink Point-to-Point with Premium Real Time Class of Service (10Mbps to 100Mbps), subject to the following conditions:
 - i) the A and B-ends of the new circuit must be the same as that of the 2Mbps DigiLink circuit;
 - ii) the consolidated bandwidth of the 2Mbps DigiLink circuits should not be higher than the bandwidth of the new circuit;
 - iii) the contract value of the new circuit must not be lower than the remaining consolidated contract value of the 2Mbps DigiLink circuit(s); and
 - iv) all new circuits will have to subscribe to a new contract term with effect from the date the service is migrated.
 - b) Migration of 155Mbps DigiLink to 300Mbps MetroEthernet Point-to-Point service subject to the following conditions:
 - the A and B-ends of the new circuit must be the same as that of the 155Mbps DigiLink circuit;
 - ii) the contract value of the new circuit must not be lower than the remaining contract value of the 155Mbps DigiLink circuit; and
 - iii) all new circuits will have to subscribe to a new contract term with effect from the date the service is migrated.

- c) Migration of MetroEthernet Point-to-Point service to Meg@POP EVPL EthernetLink Point-to-Point with Premium Real Time Class of Service subject to the following conditions:
 - i) the A and B-ends of the new circuit must be the same as that of the MetroEthernet Point-to-Point circuit;
 - ii) the contract value of the new circuit must not be lower than the remaining contract value of the MetroEthernet circuit; and
 - iii) all new circuits will have to subscribe to a new contract term with effect from the date the service is migrated.
- d) Migration of Meg@POP DSL to Meg@POP IPVPN eLite or IPVPN EthernetLink subject to the following conditions:
 - i) the contract value of the new circuit must not be lower than the remaining contract value of the DSL circuit;
 - ii) the IPVPN eLite or IPVPN EthernetLink service must be used to serve the same end user as the DSL service;
 - iii) the A and B-ends of the new circuit must be the same as that of the DSL circuit; and
 - iv) all new circuits will have to subscribe for a new contract term with effect from the date the service is migrated.
- e) Migration of Meg@POP IPVPN eLite to Meg@POP IPVPN EthernetLink service subject to the following conditions:
 - i) the contract value of the new circuit must not be lower than the remaining contract value of the Meg@POP eLite circuit;
 - ii) the Meg@POP IPVPN EthernetLink service must be used to serve the same end user as the eLite service:
 - iii) the A and B-ends of the new circuit must be the same as that of the IPVPN eLite circuit; and
 - iv) all new circuits will have to subscribe for a new contract term with effect from the date the service is migrated.
- f) If the termination is due to demolition of the building the service(s) is housed in. The customer shall produce a letter from the building management evidencing the same in order to obtain a waiver of the premature termination charges. In the event that the customer wishes to relocate the affected service(s) to a new location, the customised one-time installation charge will apply. Such relocated circuits need not be renewed on a new contract term.

Eligibility:

- 1. The Customised Scheme is offered to the customer and one (1) wholly owned subsidiary only.
- 2. The Customised Scheme is offered to any customer who satisfies the following criteria:
 - a) if subscribing to Service Package 1:
 - uses the services for connecting to its own mobile base station(s), wireless base station(s) and/or its operations centre;
 - b) if subscribing to Service Package 2:
 - is duly licensed as an Internet Service Provider in Singapore and remains licensed for the duration of the Customised Scheme and circuit contract terms;
 - uses the services subscribed under the Customised Scheme for the sole purpose of providing Internet service to end-users; and
 - installs the services subscribed under the Customised Scheme on its own network;
 - c) is a duly licensed Facilities Based Operator or Service Based Operator; and
 - d) accepts the terms and conditions of the Customised Scheme in its entirety.
