- 1. Should the customer require a dedicated network upgrade management team comprising project managers and field engineers to manage and facilitate the service upgrade for Meg@POP services; and require the team to attend onsite at any time including weekends and public holidays, the one-time charge is \$790 per circuit. For the avoidance of doubt, the charge is only applicable to circuits that are upgraded.
- 2. The minimum contract term for the Customised Scheme and each circuit subscribed under the Customised Scheme is one (1) year with an option to renew the contract term on a monthly basis up to a maximum of twenty-four (24) months.

#### **Terms and Conditions:**

- 1. The minimum volume commitment is as follows:
  - (a) 350 x Meg@POP EthernetLink circuits of at least 20Mbps;
  - (b) 350 x Business Class of Service of at least 15Mbps;
  - (c) 350 x Premium Non Real-Time Class of Service of at least 5Mbps;
  - (d) 8 x Meg@POP EthernetLink circuits of at least 300Mbps;
  - (e) 8 x Premium Non Real-Time Class of Service of at least 300Mbps; and
  - (f) 1 x 1.25Gbps GigE GigawaveLite.
- 2. In the event that any volume commitment is not met at the end of the Customised Scheme contract term, all the customised prices will revert to the prevailing list prices and SingTel shall be entitled to seek reimbursement from the customer for services already delivered.

- 3. The customer shall fulfill a minimum contract term of one (1) year for the Customised Scheme.
- 4. The customer is not allowed to resell the services subscribed under the Customised Scheme.
- 5. There shall be no auto-renewal for the Customised Scheme.
- 6. During the implementation and network transition period, SingTel may have to temporarily upgrade the customer's existing head-end services to a higher bandwidth for a maximum period of six (6) months. The customer will not be charged for the upgraded bandwidth, instead it will continue to pay the existing monthly recurring charge.
- 7. All other terms and conditions of the SingTel Meg@POP EthernetLink, Class of Service, MetroEthernet and GigawaveLite services shall remain applicable.

#### **Suspension and Termination Provisions:**

- 1. In the event that the customer terminates a circuit subscribed under the Customised Scheme prior to the end of the contract term, the customer shall be liable for a premature termination charge of 100% of the remaining contract value.
- 2. For any existing service(s) that is re-contracted or upgraded under the Customised Scheme, the applicable premature termination charge will be waived.

## **Eligibility:**

The Customised Scheme will be offered to customer who satisfies the following criteria:

- has been maintaining and continues to maintain a good payment history with SingTel; and
- accepts the terms and conditions of the Customised Scheme in its entirety.
