1. The customer may only subscribe to five (5) MetroEthernet circuits at any time during the Customised Scheme contract term. For the avoidance of doubt, the MetroEthernet circuits can be a combination of one (1) and two (2) year contract terms.
2. The contract term for the Customised Scheme is two (2) years and each circuit subscribed under the Customised Scheme is one (1) year.
3. The customised charges will continue to apply to existing circuit(s) for a period of one (1) year after the expiry of the Customised Scheme contract term. For the avoidance of doubt, new circuits may not be subscribed at the customised charges during this period. Any new circuits required may be subscribed at the list price or promotional price (where available).

Terms and Conditions:

1. The customer must commit to a monthly revenue of \$126,750 comprising of the total monthly recurring charges from the services in table (b) within eight (8) months from the date the first circuit is activated.
2. In the event that the customer fails to meet this commitment, the customer shall pay SingTel six (6) times the shortfall as at the 8th month.
3. For the avoidance of doubt, the customer is not required to maintain this revenue commitment after the 8th month.
4. There shall be no auto-renewal for the Customised Scheme.
5. The service(s) subscribed under the Customised Scheme is subject to resource availability. If any remote access facilities is required or any customisation requirements or any sites under outdoor (example sites that not located in a building that has controlled temperature and humidity, at roadside, rooftop, open corridor and location that exposed to direct sunlight and/or rain), customer will be quoted separately.

6. The customer shall not resell the service(s) subscribed under the Customised Scheme.
7. All other terms and conditions of the SingTel Meg@POP and MetroEthernet services shall apply.

Eligibility:

The Customised Scheme will be offered to any customer who satisfies the following criteria:

- commits to a monthly revenue of \$126,750 comprising of the total monthly recurring charges from the services in table (b) within eight (8) months from the date the first circuit is activated; and
- accepts the terms and conditions of the Customised Scheme in its entirety.
