Description: Customised DigiNet, MetroEthernet and GigawaveLite Scheme (**Customised Scheme**)

Prices (including discounts):

The contract term for the Customised Scheme is three (3) years.

a) DigiNet and MetroEthernet

Annual combined spending on DigiNet and MetroEthernet services	Annual Rebate (%)
\$1,500,000 to \$1,699,999	11%
\$1,700,000 to \$1,899,999	16%
\$1,900,000 to \$2,099,999	18%
\$2,100,000 and above	20%

b) GigawaveLite

Annual spending on GigawaveLite services	Annual Rebate (%)
\$700,000 to \$899,999	11%
\$900,000 to \$1,099,999	12%
\$1,100,000 and above	13%

Terms and Conditions:

1. There shall be no auto-renewal for the Rebate Scheme.
2. Only spending on the following DigiNet, MetroEthernet and GigawaveLite services shall be eligible for the Rebate Scheme:
 - a. Services that are subscribed at the prevailing list price (including any applicable term discounts).
 - b. Services subscribed under the customised DigiNet High-Speed Grooming service scheme dated 10 June 2010.

For the avoidance of doubt, services subscribed under promotions or with discounts such as but not limited to discretionary and volume discounts or at customised prices other than the customised scheme listed above shall not be eligible for the rebates but will be included in the calculation of the annual spend as set out above.

3. The Rebate Scheme shall only be applicable on monthly subscription charges.
4. The DigiNet, MetroEthernet and GigawaveLite spending are exclusive of all taxes (including goods and services and other value added taxes), duties, levies and similar charges.
5. Grooming value added services, Network Terminating Units (NTUs), Direct Interface Facilities (DIFs) and other value added services or facility charges shall not be eligible for rebates but will be included in the calculation of the annual spend as set out above.
6. Only spending on DigiNet, MetroEthernet and GigawaveLite services used solely for the purpose of connecting to an international gateway for the provision of international services, with one end connecting to the customer's POP, will be eligible for rebates.
7. DigiNet, MetroEthernet and GigawaveLite services subscribed by another subsidiary or the parent company of the customer shall not qualify for the Rebate Scheme.
8. Upon expiry or termination of the Rebate Scheme, the customer will be subject to the services' prevailing terms and conditions and the Rebate Scheme will not apply.

Eligibility:

The Customised Scheme will be offered to any customer who satisfies the following criteria:

- is a duly licensed Facilities-Based Operator (FBO) or Service-Based Operator (SBO);
- currently has a combined minimum annual spend of \$1.5M on DigiNet and MetroEthernet services subscribed at the prevailing list price and/or a minimum annual spend of \$700,000 on GigawaveLite services subscribed at the prevailing list price; and
- accepts the terms and conditions of the Customised Scheme in its entirety.
