Name of Service: Data Centre Interconnect Service

Description: Data Centre Interconnect (DCI) Service Trial (**Trial**)

Prices (including discounts):

The DCI Service is a connectivity service between data centres that is ‘on-demand’ in nature. It comprises two (2) main components – a mandatory fixed bandwidth component and a dynamic bandwidth component. The DCI service also offers a Scheduling feature which allows customers to schedule the date and time for bandwidth provisioning, termination, upgrade and downgrade.

1. The Fixed Bandwidth MRC and the Dynamic Bandwidth hourly charge will be waived for the first two (2) months of each customer’s trial period.
2. The maximum total Fixed Bandwidth and Dynamic Bandwidth activated per circuit shall not exceed 1Gbps.

Key Terms and Conditions:

1. Singtel reserves the right to impose an OTC of \$500 in the event that the customer does not activate the Dynamic Bandwidth at least once during the trial period. The OTC will be charged at the end of the customer's trial period.
2. The customer must commit to a minimum trial period of one (1) month.
3. The customer must conclude their trial by 15 August 2016. Thereafter, should the customer wish to continue using DCI, the customer may subscribe to the commercial DCI service (where available).
4. The service terminates at the Meet Me Room (MMR) and the customer is responsible for obtaining the necessary cross connects from the data centre provider and shall bear all corresponding charges. For the avoidance of doubt, the proposed tariffs apply only to the inter-data centre connectivity and do not include the cost of cross-connect services within the data centre or any other ad-hoc cost(s).
5. The trial is subject to resource availability.
6. Singtel reserves the right to cease accepting trial participants before 30 June 2016.
7. Singtel reserves the right to cease the trial before 15 August 2016.

Suspension and Termination Provisions:

In the event that the customer terminates the service within the one (1) month trial period, the customer shall pay the full MRC for the month.

Eligibility:

The customer must co-locate at any two (2) data centres listed above.
