The waiver of OTC is only for standard installation of the Meg@POP circuit. Other charges such as express installation and relocation charges of the Meg@POP circuit are not included.

Key Terms and Conditions:

- 1. The contract term of the Customised Package will be 5 years.
- 2. The minimum contract term of all Meg@POP circuits subscribed under the Customised Package will be 5 years.
- 3. The customer must implement the Meg@POP circuits within 12 months from the date of provisioning of the first Meg@POP eLite circuit in order to enjoy the proposed customised tariffs. In the event that the customer does not meet this, the customer will be required to pay SingTel a shortfall as follows:
 - Shortfall = [(55 actual number of Meg@POP IPVPN eLite circuits subscribed) * \$130 * 60 months]
 - + [(1 actual number of Standard Meg@POP IPVPN EthernetLink circuit subscribed) * \$1,400 * 60 months

- Customers who wish to upgrade their existing bandwidth during the contract term and require a change of router to another router provided by SingTel shall be charged a onetime charge of \$350.
- 5. If the customer requires the Meg@POP IPVPN eLite service to be provisioned at locations where resources are unavailable, SingTel will provide the customer with an equivalent Meg@POP BizLink service (subject to resource availability) at the said location at the same customised rates.
- 6. The customer shall not resell the Customised Package "as is" or as a standalone Meg@POP product, but may bundle the services offered under the Customised Package as part of its own network service.
- 7. The Customised Package is subject to resource availability.
- 8. No other discounts, including term and volume discounts, or promotions shall be applicable to the Customised Package.
- 9. There will be no auto renewal of the Customised Package. For any service required after the contract term, the customer will have to re-negotiate with SingTel.
- 10. All other standard prices, terms and conditions of SingTel Meg@POP service, Meg@POP IPVPN eLite service and Meg@POP IPVPN EthernetLink service shall remain applicable.

Suspension and Termination Provisions:
