1. The prevailing one-time charge applies unless stated otherwise.
2. The proposed prices are only applicable to new and renewed circuits.
3. (With effect from 18 February 2014) The contract term for the Customised Scheme is two (2) years with an option to further extend the contract term for up to two, three (3) months (Extension Period).
4. The minimum contract term for each circuit subscribed under the Customised Scheme is one (1) year and the minimum contract term for the CoS is one (1) month.
5. The contract term for each Multiple VLAN circuit is one (1) month. Thereafter, the circuit will continue on a rolling month basis until the customer terminates the circuit

or the customer terminates the Point-to-Multipoint MetroEthernet service that the VLAN circuit is tied to.

6. Tables (a), (b), (f) and (g): 3% term discount off the monthly recurring charge for a contract term of 2 years and 5% term discount off the monthly recurring charge for a contract term of 3 years or more.
7. Table 2.1(h): 5% term discount off the monthly recurring charge for a contract term of 2 years and 10% off the monthly recurring charge for a contract term of 3 years or more.

### **Terms and Conditions:**

1. (With effect from 18 February 2014) The minimum annual revenue commitment for the Customised Scheme is \$8M on the services subscribed under the Customised Scheme. The minimum revenue commitment for each Extension Period is a total of \$1.99M on domestic data services.
2. For the avoidance of doubt, spending on one-time charges, premature termination charges and value added services (e.g. bandwidth on-demand, disaster recovery, network terminating units, direct interface facilities, grooming charges etc.) will not be considered as part of the revenue commitment.
3. In the event that the customer fails to meet the revenue commitment for the relevant year, the customer shall pay SingTel the shortfall for that year.
4. There shall be no auto-renewal for the Customised Scheme.
5. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as a standalone MetroEthernet, DigiNet, Gigawave or Meg@POP service but may use the service as part of its own network to offer its own services.
6. One-end of the services subscribed under the Customised Scheme must be connected to the customer’s POP, for the sole purpose of connecting to an International Gateway to provide international services.
7. No other discounts except those specified herein shall apply.
8. All other terms and conditions of the SingTel MetroEthernet, DigiNet, Gigawave and Meg@POP services shall apply.

### **Suspension and Termination Provisions:**

1. In the event that the customer terminates a circuit subscribed under the Customised Scheme during the contract term, the customer shall be liable for a premature termination charge of 100% of the remaining contract value.

### **Eligibility:**

The Customised Scheme will be offered to any customer who meets the following criteria:

- is a duly licensed Facilities Based Operator or Services Based Operator; and
- accept the terms and conditions of the Customised Scheme in its entirety.
